The 5<sup>th</sup> Approval Committee Meeting of 2022-23 MIHAN-SEZ Nagpur was held on 10.01.2023 under the Chairmanship of Dr. V. Sraman, I.T.S., Development Commissioner, MIHAN-SEZ, Nagpur in the Conference Hall, Office of DC, MIHAN SEZ, Central Facility Building, MIHAN SEZ (via Video Conferencing).

**The decisions taken during the meeting are as under.**

**Agenda No.1- Confirmation of the minutes of the last meeting.**

The Committee confirmed the minutes of last meeting held on 08.09.2022

**Agenda No.2- Application of M/s. Jai Armaments Ltd. - Approval for default List of Services.**

After detailed discussion and deliberation, the Committee approved the default list of services (67 Services) Services required for authorized operations in terms of MOC&I letter No. D.12/19/2013-SEZ dated 16.09.2013 as amended vide letter dated 02.01.2018 and 08.05.2019.

**Agenda No.3- Application of M/s. Kolland Developers Pvt. Ltd. - For Approval of Licensing Services for the Right to use Computer Software and Databas .**

After detailed discussion and deliberation, the Committee approved the list of service viz. Licensing Services for the Right to use Computer Software and Database - SAC 997331 required for authorized operations under SEZ Rule 12 of SEZ Rules, 2006. As per MOC&I vide F.No. D.12/19/2013-SEZ dated 08.05.2019.



**Agenda No.4- Application of M/s. Infosys Ltd. (Co-Developer)- Approval of List of Material required for authorized operations i.e. construction of new building.**

After deliberation, the Committee approved the list of good as shown in list to the letter dated 16.09.2022 in terms of Rule 10 of SEZ Rules, 2006 which is duly certified by the Chartered Engineer required for authorized operation in the SEZ for the value of Capital goods valued at Rs. 13,59,03,930 /-

**Agenda No.5- Application of M/s Infosys Ltd. (SEZ Unit-II) Approval of change of location form M/s Kolland Developers Pvt. Ltd. Building A1, 5<sup>th</sup> Floor, SP Infocity, Sector-1, MIHAN-SEZ to M/s Infosys Ltd (Co-Developer) SDB- -2, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> Floor, Plot No.7, Sector-17, MIHAN-SEZ in the LOA with Revisions of Projection MIHAN SEZ.**

The representative of the Unit briefed the Committee about the change the location from M/s Kolland Developers Pvt. Ltd. Building A1, 5<sup>th</sup> Floor, SP Infocity, Sector-1, MIHAN-SEZ to M/s Infosys Ltd (Co-Developer) SDB- -2, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> Floor, Plot No.7, Sector-17, MIHAN-SEZ.

After deliberation, the Committee approved the proposal for change of location as proposed by the unit and also Revision of Projection for 2 years (2023-24 and 2024-25), envisaging FOB value of exports of Rs.12600/- Lakhs, FE Outgo of Rs.6250/- Lakhs and NFE achievement of Rs.6350/- Lakhs over a period of 5 years with employment generation 2158 Men & 1322 Women. The unit shall comply with the provisions of SEZ Act/Rules including Customs Act/Rules in respect of proposed activity.

**Agenda No.6- Application of M/s. Sagacious IP Pvt. Ltd. - approval for Inclusion of additional location in the LOA with Revision of Projection for the remaining period of Two years.**

The representative of the unit stated that due to expansion of the existing capacities and in order to meet the upcoming orders the unit has decided to add additional location in the LOA. The Developer has issued provisional allotment of adjacent space.

After detailed discussion and deliberation, the Committee approved the proposal of M/s Sagacious IP Pvt. Ltd. for additional location in the Letter of Approval dated 03.03.2014 required for authorized operations.i.e. Office No. 01, 3rd Floor, A-Wing, South Block, Central Facility Building, MIHAN SEZ with Revision of Projection for 2



years (2023-24 and 2024-25), envisaging FOB value of exports of Rs.1789.66/- Lakhs, FE Outgo of Rs.17.90/- Lakhs and NFE achievement of Rs.1771.76/- Lakhs over a period of 5 years with employment generation 58 Men & 30 Women. The Committee also directed to initiate action for purchase of land, construction of their factory building in MIHAN SEZ.

**Agenda No.7- Application of M/s GlobalLogic India Pvt. Ltd. approval for Inclusion of additional location in the LOA.**

The representative of the unit stated that the unit has completed 10 years in the incubation building and the MADC is reluctant to further extend their lease deed therefore their management has decided to obtain the additional space at 4<sup>th</sup> Floor, A-1 Building at SP Infocity SEZ, Sector-11, Plot No. 2, MIHAN-SEZ, Nagpur (50,269 Sq.ft.). The unit has decided to add additional location in the LOA that entire SEZ operation can be handled and administered from one common building & floor only instead of separate buildings & floors as of now. This will also lead to ease in day to day operations with reduction in operational cost. The Co-Developer has issued Letter of Intent to lease.

The unit has further stated that they have already completed 3.5 years of operation of 2<sup>nd</sup> Block, and their renewal is due in 2024, and fit out work for proposed additional location will take another 5-6 months of time, once the fit out is completed they will shift their entire office operations to proposed additional location i.e. at 4<sup>th</sup> Floor, A-1 Building at SP Infocity SEZ, Sector-11, Plot No. 2, MIHAN-SEZ, Nagpur (50,269 Sq.ft.). Also they will submit separate application to this office for deletion of existing area later on.

After deliberation, the Committee approved the proposal of M/s GlobalLogic India Pvt. Ltd. for inclusion of additional location i.e. 4<sup>th</sup> Floor, A-1 Building at SP Infocity SEZ, Sector-11, Plot No. 2, MIHAN-SEZ, Nagpur (50,269 Sq.ft.).

**Agenda No.8- Application of M/s Pravesh Exports Pvt. Ltd. for inclusion of additional items in the LOA under broad-banding with Revision of Projection for the remaining period of Two years.**

The Committee was informed that Mealworm CTH 04101020 is free to export as per DGFT Policy, However Import is restricted. In this case the unit will be procuring all the items proposed for inclusions from domestic market i.e. from India. Since DTA procurement is considered Export in terms of Section 2 (m) of SEZ Act, 2005.

The DGFT condition imposed for the export of Peanuts is as under **“(a)Export to all countries (except exports to Russian Federation) is permitted subject to registration with APEDA along with controlled Aflatoxin level Certificate issued**



by APEDA recognized laboratories (as updated from time to time) on their website at URL [http://www.apeda.gov.in/apedawebsite/HACCP/recognized\\_laboratories.pdf](http://www.apeda.gov.in/apedawebsite/HACCP/recognized_laboratories.pdf) (b) Exports to Russian Federation permitted subject to pre-shipment quality certification issued by (1) Insecticide Residue Testing Laboratory. (2) Geo-Chem Laboratories Pvt. Ltd. (3) Reliable Analytical Laboratory (4) Arbro Pharmaceuticals Ltd. (5) Shri Ram Institute for Industrial Research, Delhi (6) Shri Ram Institute for Industrial Research, Branch Office Bangalore (7) Delhi Test House; and (8) Vimta Labs. or any other agency as may notified from time to time."

After detailed discussion and deliberation, the Committee approved the proposal of M/s. Pravesh Exports Pvt. Ltd. for inclusion of additional items under broad-banding in Letter of Approval dated 07.10.2013 in terms of Rule 19(2) of SEZ Rules, 2006 items viz. 1. Cranberries (ITC HS Code 20089300) 2. Cuttlefish Bone (ITC HS Code 05080040) 3. Peanut (ITC HS Code 20081100) 4. Mealworm (ITC HS Code 04101020) 5. Pineapple (ITC HS Code 20082000) 6. Raisins-Dry Grape (ITC HS Code 08062010) 7. Chia Seeds (ITC HS Code 12099190) with Revision of Projection for 2 years (2023-24 and 2024-25), envisaging FOB value of exports of Rs.9898/- Lakhs, FE Outgo of Rs.1300/- Lakhs and NFE achievement of Rs.8598/- Lakhs over a period of 5 years with a condition that the unit shall follow the SEZ Act/Rules, Customs Laws and other statutory provisions of other Act/Rules as applicable for the proposed activity.

**Agenda No.9- Application of M/s Infocepts Technologies Pvt. Ltd. approval for Surrendering of space located at 2<sup>nd</sup> Floor, C-Wing, South Block, CFB, MIHAN-SEZ from LOA.**

After deliberation, the Committee approved the proposal of M/s Infocepts Technologies Pvt. Ltd. for deletion of space 9330.50 Sq.ft. located at 2<sup>nd</sup> Floor, C-Wing, South Block, Central Facility Building, MIHAN-SEZ, Nagpur from their existing Letter of Approval dated 08.10.2015 and also their request for transfer of the assets as mentioned in the Annexure- A (transfer of assets from the premises proposed for deletion to the existing premises of the same unit situated at SP Infocity, MIHAN-SEZ), Annexure- B (DTA Sale) & Annexure- D (transfer of assets from the premises proposed for deletion to the unit-I, M/s Infocepts Technologies Pvt. Ltd. situated at 2<sup>nd</sup> Floor, C-Wing, South Block, CFB, MIHAN-SEZ to Unit-II space 2<sup>nd</sup> Floor, C-Wing, North Block, CFB, MIHAN-SEZ) of the Exhibit-I as mentioned in the Point No. i, ii & iv of the letter No. ITPL/2021-22/SEZ-I/022 dated 15.11.2022. In terms of Rule 19(2) of SEZ Rules, 2006, **“Provided that the Approval Committee may also approve proposal for broad-banding, diversification, enhancement of capacity of production, change in the items of manufacture or services activity”**.

In this regard, the unit submitted that the goods will be supplied on the basis of the delivery challan by the domestic market supplier without any consideration as the same are to be procured only for milling services. The unit also stated that since there is not procurement/purchase there is no IGST implication. After milling services the same will be transferred back to the same supplier on the basis of the Gate pass and w.r.t. IGST treatment since it is mere return of the goods to the same domestic party there is no IGST implication. For the services the unit will raise the invoice in foreign currency i.e. USD and the invoice will be raised after the complete activity.

Further, the unit also stated that they have suitable arrangement for keeping the milling services goods and other goods procured/imported for current authorized operation. Also separate books of accounts will be maintained. Further, a separate register will be maintained for goods sourced for service activity. The unit further submitted
