Agenda Items & Decisions

Agenda No. 1 – Confirmation of Minutes of the Last Meeting

Decision: The Committee noted and confirmed the minutes of the 3rd Approval Committee Meeting held on 17.12.2024 without any modifications.

Agenda No. 2 – Proposal of M/s. Perla IT for setting up a new unit at MIHAN-SEZ

Decision: The Committee approved the proposal, subject to the condition that the unit must submit the provisional land allotment letter from MADC before proceeding further.

Agenda No. 3 – Proposal of M/s. ADCC Infocom Pvt. Ltd. for setting up a new unit at MIHAN-SEZ

Decision: The Committee deferred the proposal and decided that it will be reconsidered in the next Unit Approval Committee (UAC) meeting after submission of the allotment letter issued by MADC in the name of the proposing unit.

Agenda No. 4 – Proposal of M/s. CloudScience Labs Pvt. Ltd. for setting up a new unit at MIHAN-SEZ

Decision: The Committee approved the proposal, subject to fulfillment of all conditions of the Letter of Approval (LoA).

Agenda No. 5 – Proposal of M/s. Peepul Global Services Pvt. Ltd. for setting up a new unit at MIHAN-SEZ

Decision: The matter was discussed in detail. The applicant's previous application was also brought to the notice of the Committee. The current application for establishment of IT/ITES service unit was approved, subject to the following conditions:

- (i) The unit must submit the export orders of Rs. 20 lakh, as mentioned by the applicant before the committee in the meeting.
 - (ii) The unit must submit a quarterly progress report for the next one year to monitor performance.
 - (iii) The firm is required to submit educational qualifications and relevant documents of its employees who would work in the proposed unit.

Agenda No. 6 – Proposal of M/s. Masters Medical Solutions Pvt. Ltd. for setting up a new unit at MIHAN-SEZ


Decision: The Committee approved the proposal for setting up a new unit at MIHAN-SEZ.

Agenda No. 7 – Proposal of M/s. Lighthouse Info Systems Pvt. Ltd. for surrender of office space

Decision: The Committee deferred the matter. It will be considered in the next Approval Committee meeting after the applicant firm is able to submit a No Objection Certificate from the developer, MADC and the Specified Officer.

Agenda Nos. 9 & 10 – Applications of M/s. HCG Nagpur Pvt. Ltd. for movement permissions related to pipeline work

Proposal: M/s. HCG Nagpur Pvt. Ltd. had submitted two separate applications seeking approval for:

1. **Agenda No. 9** – Permission for movement of employees/staff involved in the **laying of an 8” diameter gas pipeline** in MADCL jurisdiction.
2. **Agenda No. 10** – Permission for movement of **vehicles, machinery, and workers** for the same project under a work order given to M/s. White Pearl Enterprises.

Decision: Rejected – The matter was discussed in detail. The view of the MADC was that the proposal for any such development should have come as an infrastructure service provider. Accordingly, since the matter pertains to **infrastructure development**, the Committee decided that such projects require the applicant to **apply under the status of co-developer** which can then be recommended by the DC to the Board of Approval under rule **3A of the SEZ Rules, 2006**.

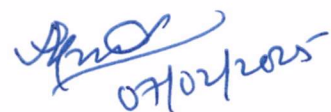
Table Agenda Items & Decisions
