The meeting commenced with the submission of proposal for renewal of LOA issued to Abhijeet MADC Nagpur Energy Pvt. Ltd. ('AMNEPL') in the name of M/s Abhijeet MADC Nagpur Energy Pvt. Ltd.

The Committee reviewed the proposal and identified some deficiencies that need to be addressed.

The Specified Officer, Customs highlighted concerns regarding operation of the entity without a valid LOA and recovery of pending customs duty.

The Legal Officer, MADC raised objections through their Letter dated 15.02.2024 such as pending appeal by MADC in NCLAT and non-recognition of M/s. Rankini Power generation Pvt. Ltd. as a project company.

The Committee deferred the proposal by directing MADC to provide clarification regarding the entity presently operating the power plant for such operation in the Zone and the details of payment. The Specified Officer, Customs was directed to seek legal opinion on recovery of pending customs duty.

It was informed to the Committee that based on the data provided in the APR duly certified by the Chartered Accountant; the performance of the Unit has been monitored.

After deliberation, the Committee noted the performance of the Unit. AGENDA NOTE FOR CONSIDERATION OF THE APPROVAL COMMITTEE

Proposal: Renewal of Letter of Approval No. SEEPZ/NEW SEZ MADC-NGP/13/2009-10/9317 dated 02.09.2009 of M/s. Abhijeet MADC Nagpur Energy Pvt. Ltd.

Deferred Agenda No. 10: Minutes of the last UAC Meeting held on 21.02.2024.

Background: M/s Abhijeet MADC Nagpur Energy Pvt. Ltd. ('AMNEPL') was granted LOA vide No. SEEPZ/NEWSEZ/MADC-NGP/13/2009-10/9317 dated 02.09.2009. The said LOA expired on 28.02.2018 and was not renewed. Following the Order of the Hon'ble NCLT, Rankini Power Generation Pvt. Ltd. ('RPGPL') has acquired AMNEPL and has approached the Office of the Development Commissioner, MIHAN-SEZ for renewal of LOA on 02.01.2024 and 10.11.2023. The proposal was discussed in the last UAC meeting held on 21.02.2024.

Discussion Summary: During the UAC meeting, the following concerns were raised:

- The Specified Officer, Customs highlighted concerns regarding the operation of the entity without a valid LOA and the recovery of pending customs duty.
- The Legal Officer, MADC raised objections regarding pending appeals in NCLAT and non-recognition of M/s. RPGPL as a project company.
- The Unit Approval Committee deferred the proposal, directing MADC to provide clarification regarding the entity presently operating the power plant in the Zone and details of payment. The Specified Officer, Customs was directed to seek legal opinion on the recovery of pending customs duty.

Actions Taken: Following the UAC meeting held on 21.02.2024:

- 1) The applicant entity submitted a Letter on 05.03.2024, addressing the issues raised by MADC and Customs representatives.
- 2) The Specified Officer issued a letter to MADC on 06.03.2024 requesting the following: (i) Urgent clarification on how the ongoing operations of AMNEPL are being monitored (ii) Requesting arrangements to take action to safeguard revenue interest and recover Government revenue and deposit the same with Government Exchequer.
- 3) The Specified Officer, Customs issued a Letter to the Development Commissioner requesting to obtain a specific undertaking from AMNEPL and RPGPL, and a BLUT from RPGPL for safeguarding the revenue interest of Customs.
- 4) The Development Commissioner's Office issued a Letter to M/s MADC dated 08.03.2024, and directed the representatives of MADC to attend the next UAC meeting proposed to be conducted on 14.03.2024 and state the position of MADC on the agenda.

The case is put up before the Unit Approval Committee for taking a decision on whether the LOA can be renewed in the name of M/s AMNEPL, the liquidated entity or M/s RPGPL, the acquirer of AMNEPL following the Order of the NCLT dated 28.04.2023. The Committee may also consider the fact that MADC held a 26% stake in M/s AMNEPL, and they had also issued a Letter of Comfort dated 19.03.2018 to the Resolution Professional, expressing willingness to co-operate in the insolvency resolution process.

The Committee may also consider the fact that in the absence of LOA, the activity of operation of the 'step down transformer' and providing electricity to the Zone by any entity would become illegal and thereby, the power supply to the Zone would get affected.
