Agenda No.1- Confirmation of the minutes of the last meeting.

The Committee confirmed the minutes of last meeting held on 23.12.2020.

Agenda No.2- Application of M/s Indo UK Healthcare Pvt. Ltd. – inclusion of additional items in the LOA under broad-banding.

After deliberation, the Committee approved the proposal for broad-banding of items viz.

a. Single Use Surgical Mask - 44,10,00,000 Nos. P.A. (ITCHS- 90189099)

With revision of projection envisaging FOB value of exports of Rs.246883/- Lakhs, FE Outgo of Rs.70048/- Lakhs and NFE achievement of Rs.176834/- Lakhs for 5 years period years.

Agenda No.3- Application of M/s Thales Reliance Defence Systems Ltd. – inclusion of additional items in the LOA under broad-banding.

After deliberation, the Committee approved the proposal for broad-banding of items viz. Repair/Replacement of LRU's/SRU's and PCBA's with a condition that the

After deliberation, the Committee noted the performance of the Unit. The Committee also noticed that the Unit has not achieved positive NFE on cumulative basis during the period 2018-19 & 2019-20 in terms of Rule 54 of SEZ Rules, 2006. The Unit shall also get reconcile the Import/Export data vis-à-vis SEZ Online Data with Specified Officer, MIHAN SEZ.

Agenda No.6- Monitoring of Performance of M/s. Tech Mahindra Ltd. for the block period 2017-18 to 2021-22.
