**Agenda No. 01 – Confirmation of Minutes of the Last Meeting**

**Decision:** The Committee noted and confirmed the minutes of the 1<sup>st</sup> Unit Approval Committee Meeting (2025-2026 Series) held on 08.04.2025 without any modifications.

**Agenda No. 02 – Proposal of M/s. Tata Advanced Systems Ltd. for inclusion of additional land i.e. Plot No. 02, Sector – 10, admeasuring area of 1,21,405 Sqmtr (Equivalent 30 Acers) MIHAN-SEZ, Nagpur in the LOA.**

**Decision:** The Committee noted that the Developer has issued provisional offer allotment letter to the unit. After deliberation, the Committee **approved the proposal** of M/s Tata Advanced Systems Ltd. for inclusion of additional land i.e. Plot No. 02, Sector-

10, admeasuring area of 1,21,405 Sqmtr (equivalent 30 acres) MIHAN-SEZ required for authorized operation in the Letter of Approval dated 03.12.2007.

**Agenda No. 03 – Proposal of M/s. KC Overseas Pvt. Ltd. for inclusion of additional location Office No. 08, Ground Floor, C-Wing, North Block, Central Facility Building, MIHAN-SEZ, Nagpur.**

**Decision:** The Committee noted that the Developer has issued provisional allotment letter to the unit. After deliberation, the Committee **approved the proposal** of M/s KC Overseas Pvt Ltd. for inclusion of additional location i.e. Office No. 08, Ground Floor, C-Wing, North Block, Central Facility Building (area admeasuring 573 sq.ft) MIHAN-SEZ required for authorized operation in the Letter of Approval dated 09.05.2022. It was made clear to the firm that the commencement of production, if any, from this additional space would be construed as commencement of production of the entity in MIHAN SEZ.

**Agenda No. 04 – Proposal of M/s. Kale Impex Pvt. Ltd. for revision in projection and revised values for Capital Goods, Raw Materials, and Services in the LOA under broad-banding.**

**Decision:** After detailed discussion and deliberation, the Committee **approved the proposal** of M/s Kale Impex Pvt. Ltd. for revision in projection with revised values for Capital Goods, Raw Materials and Services in the LOA i.e. envisaging FOB value of exports Rs.5893.79/- Lakhs, FE outgo of Rs.2500.00/- Lakhs, and NFE achievement of Rs.3393.79 and also Capital Goods of Rs.1300.00/- Lakhs, Raw Material Rs. 5000.00/- Lakhs, and Services Rs.1600.00/- Lakhs over a period of 5 years with a condition that the unit shall follow the SEZ Act/Rules, Customs Laws and other statutory provisions of other Act/Rules as applicable for the authorized operation.


**Agenda No. 07 – Trade Notice No. 01/2025-26 of MIHAN-SEZ, Nagpur.**

**Decision:** The Committee was informed about the Trade Notice No. 01/2025-26 dated 22.04.2025 issued by this office for setting up of cafeteria. It was also informed that only M/s Tata Consultancy Services Ltd., M/s HCL Technologies Ltd., and M/s Hexaware Technologies Ltd has submitted information about their cafeteria. The Committee directed the ADC & Customs officials to systematically survey all the units and submit a report within 15 days, so that the Committee can decide the next course of action for defaulters.

**Agenda No. 08 – Any other matter which may be raised by the members with the permission of DC.**

**Decision:** The member from Labour Commissioner's office made a request that whenever a new Company starts their operation, they should intimate to their office. This was taken note and it was decided that commencement of production of any unit must, as a general practice, be informed to Committee members, going forward in the UAC meeting. It was also that after an initial discussion, the DC Office and Labour Commissioner Office may start the periodic review of MIHAN SEZ units as per the Labour Code guidelines.

**a) Proposal: -**

Action on violation of terms and condition of provisions of SEZ Act 2005/ Rules 2006 and Letter of Approval dated 30.11.2023- M/s Click2Cloud Technology India Pvt. Ltd.

**b) Specific Issue on which decision of UAC is required: -**

Action on violation of terms and condition of provisions of SEZ Act 2005/ Rules 2006 and Letter of Approval dated 30.11.2023.

**c) Relevant provisions: -**

In terms of Rule 19(5) of SEZ Rules, 2006 and Section 11(2) of the Foreign Trade (Development & Regulation) Act, 1962 and Rule 7 of The Foreign Trade (Regulation) Rules, 1993.

**d) Other Information: -**

M/s Click2Cloud Technology India Pvt. Ltd. have been issued Letter of Approval No. MIHAN-SEZ/UNIT-06/LOA-05/AM-2024 DATED 30.11.2023 for setting up of IT/ITES Unit at Office No. 01 & 02, 1<sup>st</sup> Floor in C-Wing, South Block at Central Facility Building at MIHAN-SEZ.

2. As per the terms and conditions of LOA "The Letter of Approval is valid for a period of one year from its date of issue. You shall implement the project and commence production within one year period or within such period as may be extended"

3. Further in terms of Rule (19)4 of SEZ Rules, 2006 " ***The Letter of Approval shall be valid for one year within which period the Unit shall commence production or service or trading or Free Trade and Warehousing activity and the Unit shall intimate date of commencement of production or activity to Development Commissioner.***

***Provided that upon a request by the entrepreneur, the extension may be granted by the Development Commissioner for valid reasons to be recorded in writing for a further period not exceeding two year."***

4. Also in terms of Rule 19(5) of the SEZ Rules, 2006 "***If the Unit has not commenced production or service activity within the validity period under sub-rule (4), the Letter of Approval shall be deemed to have been lapsed with effect from the date on which is validity expired..***"

5. On scrutiny of the records, it is noticed that the Unit after grant of Letter of Approval did not execute the Bond cum LUT in terms of Rule 22 of SEZ Rules, 2006 and in compliance of terms and conditions of the LOA. The Unit also failed to commence operation within the validity period of the LOA nor applied for extension of validity of LOA before expiry date i.e. 29.11.2024.

6. Accordingly the Unit was issued Show Cause Notice and directed to submit the reply as to

- (i) Why a fiscal penalty should not be imposed on the unit under section 11 of the Foreign Trade (Development and Regulation) Act, 1992 as amended time



- (ii) Why the IEC of the unit should not be suspended?
- (iii) Why the matter may not be placed before the UAC for withdrawing the LOA from the Noticee ?

7. The Unit vide their letter dated 29.04.2025 submitted their reply stating that due to non completion of Lease Agreement, and Pending compliances, there is delay in full filling the stipulated conditions. The Unit has requested to grant extension of LOA.

**Recommendation:-**

The proposal action on the violation of statutory compliance by the unit in terms of provision of SEZ Act, 2005 & SEZ Rules, 2006 is placed before the Approval Committee for necessary direction in the matter.

Dear Sir,

This is with reference to the *Show Cause Notice* received from your office dated 28.04.2025 regarding the commencement of operations at our MIHAN-SEZ unit without executing the required compliances under the SEZ Act, 2005 and SEZ Rules, 2006.

At the outset, we wish to submit that the delay in initiating operations primarily arose due to delay in execution of Leave and License agreement with MADC. Accordingly, our request for extension dated 14th March 2024 had also highlighted this concern, and we have since been pursuing the formalities actively.

We sincerely regret the delay in fulfilling the stipulated conditions. We would like to submit the following for your kind consideration:

- 1. Completion of Lease Agreement:** The Leave and License agreement for our unit at Office No. 01 & 02, 1st Floor, C Wing, South Block, Central Facility Building, MIHAN SEZ, Nagpur has been executed and received today. This marks the final step that was pending and had delayed our ability to complete other critical SEZ compliances.
- 2. Pending Compliances Being Addressed:** With the lease now formalized, we are expediting the remaining compliance processes including the execution of **Bond-cum-Legal Undertaking (BLUT)** and obtaining the **Letter of Undertaking (LUT)**. These will be completed at the earliest.
- 3. Request for Extension of LOA:** In light of the above, we humbly request your good office to **grant an extension of the LOA** to enable us to regularize all pending requirements and proceed in full compliance with SEZ norms.



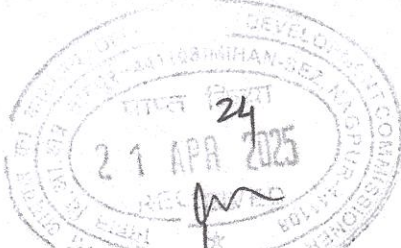
We are writing this letter to formally request an extension of the Letter of Approval (LOA) granted to our business.

### **SHOW CAUSE NOTICE**

M/s. Click2Cloud Technology Services Pvt. Ltd. (hereinafter referred as the "Unit" or the "Noticee") was issued a Letter of Approval No. **Mihan-Sez/Unit-006/LOA-05/AM-2024 dated 30.11.2023** under the SEZ Scheme for export of Computer Software Services, Software Implementation Services, System Analysis Services and System Design Services etc. subject to fulfillment of condition stipulated thereunder for commencing operations from the premises at Office No.01 & 02, 1<sup>st</sup> Floor, C Wing, South Block, Central Facility Building, MIHAN SEZ, Nagpur.

2. **AND Whereas**, on scrutiny of records, it has been found that the unit has not yet accepted the terms and conditions of the Letter of Approval and has not yet executed the mandatory Bond cum Legal Undertaking with the Development Commissioner, MIHAN SEZ.

3. **AND Whereas**, after a physical inspection of Unit premises by an officer from the DC office, it was noticed that approx. 80-85 employees are already working in the Unit premises. It was also found that such operations are running since last one year. The commencement of production without complying with the provisions of the SEZ Act, 2005 and SEZ Rules, 2006 and terms & conditions of the Letter of Approval appears to be a violation of the SEZ Acts and Rules.

4. **AND Whereas**, it is further observed that the validity of the Letter of Approval expired on 29.11.2024 and the unit has failed to apply for extension of validity also before expiry, yet has continued to operate from the premises. It is on record that the unit has not submitted a Bond or Undertaking and has not communicated about its commencement of production.

5. In terms of Rule 19(5) of the SEZ Rules, 2006 "If the Unit has not

187 commenced production or service activity within the validity period under sub-rule(4), the Letter of Approval shall be deemed to have been lapsed with effect from the date on which its validity expired”.

6. AND Whereas, in terms of Section 16 of the SEZ Act, 2005 “The Approval Committee may, at any time, if it has any reason or cause to believe that the entrepreneur has persistently contravened any of the terms and conditions or its obligations subject to which the Letter of Approval was granted to the entrepreneur, cancel the Letter of Approval”.

(iii) Why the matter may not be placed before the UAC for withdrawing the LoA from the Noticee ?

9. The unit's reply in this regard should be submitted within 15 days from the receipt of this instant Show Cause Notice failing which it will be presumed that you have nothing to state in the matter and accordingly further action shall be initiated without further communication in the matter. You may also avail the opportunity of personal hearing with the undersigned either physically between 28.04.2025 to 30.04.2025 with prior intimation or through Video conferencing for which they may intimate the DC office at MIHAN SEZ, which shall arrange a Video Conference. Please note that failure to attend the

hearing or submit a response within the stipulated time, may lead to action being initiated under the Act, ex-parte based on available documents on record without any further communication to the Unit, which may include cancellation of LoA and exit from the SEZ.

10. This Show Cause Notice is issued without prejudice to any other action that may be taken against **M/s Click2Cloud Technology Services Pvt. Ltd.** under the Foreign Trade (Development & Regulation) Act, 1992 or any other law for the time being in force.



(i) Reorganization including change of name, change of shareholding pattern, business transfer arrangements, court approved mergers and demergers, change of constitution, change of Directors, etc. may be undertaken by the Unit Approval Committee (UAC) concerned subject to the condition that the Developer / Co-developer / Unit shall not opt out or exit out of the Special Economic Zone and continues to operate as a going concern. All liabilities of the Developer / Co-developer / Unit shall remain unchanged on such reorganization.


(ii) Such reorganization shall be subject to the following safeguards.

- a. Seamless continuity of the SEZ activities with unaltered responsibilities and obligations for the altered entity;
- b. Fulfilment of all eligibility criteria applicable, including security clearances etc., by the altered entity and its constituents;

- c. Applicability of and compliance with all Revenue / Company Affairs / SEBI etc. Acts / Rules which regulate issues like capital gains, equity change, transfer, taxability etc.
  - d. Full financial details relating to change in equity / merger, demerger, amalgamation or transfer in ownership etc. shall be furnished immediately to Member (IT&R), CBDT, Department of Revenue and to the jurisdictional Authority.
  - e. The Assessing Officer shall have the right to assess the taxability of the gain / loss arising out of the transfer of equity or merger, demerger, amalgamation, transfer and ownerships etc. as may be applicable and eligibility for deduction under relevant sections of the Income Tax Act, 1961.
  - f. The applicant shall comply with relevant State Government laws, including those relating to lease of land, as applicable.
  - g. The applicant shall furnish details of PAN and jurisdictional assessing officer of the unit to CBDT.
  - h. The applicant shall be recognised by the new name or such arrangement in all the records.
