M/s Essem Compliance Solutions Pvt. Ltd. has been granted Letter of Approval No. MIHAN-SEZ/Unit-02/LOA-01/AM 2020 dated 16.05.2018 for IT and ITES. The unit commenced production w.e.f 01.07.2019. The existing block period of the unit is 2019-20 to 2023-24.

The performance of the unit is being monitored based upon the details submitted in the APRs duly certified by the Chartered Accountant. The unit is also submitting a copy of the APRs to the Specified Officer as per the terms and conditions of the Bond cum LUT.

The APRs of the unit has been monitored. The Year-wise performance of the unit is as follows:-
